BIBLIOGRAPHY OF MATERIALS ON THE JUDGE AND HIS ROLE IN AMERICAN JURISPRUDENCE

INTRODUCTION

This bibliography, designed to aid in the research of materials on the judge and his role in American jurisprudence, is limited to law reviews published by American law schools. A section on judges in foreign jurisdictions (outside the United States), however is included but the articles listed therein were not classified under other sections where they might also fit.

Much use was made of the Index to Legal Periodicals in the preparation of this bibliography. Some of the law reviews indexed therein were not available in the Tulsa University Law School Library. Consequently those materials that were not available could not be classified. Nevertheless they were listed in the bibliography for the benefit of those persons who have access to the materials and might wish to refer to them.

Persons using this bibliography should be advised that it is not exhaustive nor are the classifications mutually exclusive. Some of the materials listed touch on many subjects but they are classified according to the subjects that are emphasized in the articles.
